## Amend Game Licence

*Note: A person can only hold one Game Licence at a time which (once issued) must remain in effect until it expires or is cancelled. As such, you can only add additional species (and related entitlement) to an existing licence.*

- To add **Duck** to 'Game Birds, not including duck', you must first pass the WIT test. Your current licence will be amended at no cost.
- To add **Hounds** to 'Deer (Stalking)', you must first pass the Hound Hunting Test. Your current licence will be amended at no cost.
- To add 'Deer' to 'Game Birds' (or vice-versa) check the expiry date shown on your game licence and pay the fee shown in table below.

If your Game Licence expires on <b>31 December 2020</b>	<b>you pay \$14.80</b> If Concession, you pay \$14.80
If your Game Licence expires on <b>31 December 2021</b>	<b>you pay \$44.40</b> If Concession, you pay \$29.60
If your Game Licence expires on <b>31 December 2022</b>	<b>you pay \$74.00</b> If Concession, you pay \$44.40
If your Game Licence expires on <b>31 December 2023</b>	<b>you pay \$103.60</b> If Concession, you pay \$59.20

*Your payment of the Concession amount is your declaration that you are an eligible person within the meaning of the State Concessions Act 2004. You must be able to prove your eligibility by producing a valid Concession Card at the request of an Authorised Officer.*
